Thomas F. Lynch III is a Distinguished Research Fellow in the Center for Strategy and Military Power (CSMP), Institute for National Strategic Studies (INSS), at the National Defense University (NDU) in Washington, DC. His primary research focuses on Great Power competition, India's strategic rise, and Indo-Pacific security. Dr. Lynch has published three books including as editor of *Strategic Assessment 2020: Into a New Era of Great Power Competition* (NDU Press, 2020), more than a dozen book chapters, and 30 feature monographs and journal articles. He is a lifetime member of the Council on Foreign Relations (CFR) and an adjunct professor in the Security Studies Program at Georgetown University. Dr. Lynch holds a bachelor of science from the U.S. Military Academy at West Point, a master's of public administration, a master of arts, and a doctor of philosophy in international relations from the School of Public and International Affairs (formerly the Woodrow Wilson School) at Princeton University.

Richard B. Andres is Professor of National Security Strategy in the National War College (NWC) at NDU, where he teaches courses on strategy development, cyber strategy, and policy. His work explores the connection between emerging technology and national security strategy. Dr. Andres has served as a personal consultant on strategy to the Director of the National Security Agency–U.S. Cyber Command, Secretary of the Air Force, Commandant of the Marine Corps, and other national leaders. He has led strategy development teams for the George W. Bush and Barack Obama administrations, various combatant commands, and other government and private organizations. He is a Senior Fellow and holds board positions at several Washington think tanks and National Laboratories, including the Mitchell Institute, the American Enterprise Institute, and Pacific Northwest National Laboratory.
